### BACKGROUND INFORMATION:

The Chiropractic & Osteopathy Education Foundation Ltd. (ACN 144 901 495) was established in June 2010 as trustee of the Chiropractic & Osteopathy Education Trust.

The Trust was established utilising assets of the Chiropractic & Osteopathy Board of South Australia for various purposes including *"to support the education, training and development of students and trainees of chiropractic and osteopathy from the State of South Australia in any part of Australia"*.

The Trust has decided to endow scholarships for students of chiropractic or osteopathy domiciled in South Australia and who will be entering their final year of study in a recognised chiropractic or osteopathy course at a tertiary education institution in 2014.

Successful applicants will share in the annual allocation of funds as determined by the Trust. The Trust anticipates that a cash sum will be made available to eligible students. The amount available to each student will vary, depending on the sum allocated each year and the number of eligible students.

### ELIGIBILITY:

In order to be eligible, all students must satisfy the Trust that they meet the following criteria:

1. Successful completion of all fourth year subjects
2. Be undertaking their final year of their respective Chiropractic/Osteopathic studies FULL TIME in 2014
3. Applications will need to be countersigned by a representative of the relevant institution, confirming 1 and 2.
4. Have lived in South Australia for at least five years immediately prior to travelling interstate to undertake chiropractic/osteopathy studies
5. Submit this application form to COET by the 28th of February 2014 (COET will endeavour to disburse funds in March 2014)
